**Test:** SGS NZ was engaged by the client to carry out a repetitive pull-out load test (Fig. 1) and a shear test (Fig. 2) on the Fastmount Standard Profile Range plastic mounting systems in various

configurations.

Method: Repetitive pull-out test

The plastic clip set was subjected to cyclic pull-out loading at a rate of 100mm/min with a frequency of approximately 1 cycle per 10s. The initial pull-out force was measured and recorded and then again after 500 cycles.

Shear test

A shear force was applied to the assembled plastic clip set ensuring no separation between the male and female clips through their axis while under load.

Test Conditions - 23 ± 2°C, r.h 50 ± 10%







